**2) Questions and Answers:**

Q1: Are the anesthetic machines requested going to be used by the military? This would require a different specification as transport boxes need to be supplied as well.

A1: No, they will be used in an operating room environment.

Q2: Are we able to bid two Anesthetic Machine options in the tender?

A2: This solicitation requirement is for the supply and delivery of 2 Anesthetic Machines as detailed in Annex A -Requirement and Annex B- Basis of Payment

Also please note that in (part 1 of 2) page 2 of 2 –Line Item Details page is deleted.

Q3: Patient monitoring is not in the tender specification. Will this be tendered for later?

A3: Yes. Patient monitoring equipment will be tendered via another process.

Q4: Servicing is not included in the specification, will this be negotiated later after the warranty period has elapsed?

A4: At this time we are not pursuing a service contract.

Q5: Are you able to release an unprotected copy of the tender for completion purposes as this will ensure the format remains the same?
