1. Bidders are advised that the RFP Amendment 006 is issued to:
 - a. **EXTEND** the closing date to **DECEMBER 5, 2016 at 2:00 p.m.**; and
 - b. Publish Question and Answer 43. Questions and answers 1 to 42 were issued as part of Amendments 002, 003, 004, and 005 to the RFP.

Question 43: As noted on page 88 of 122 under Paragraph 4.2 item f) requires the bidder to submit references to verify work experience. In some cases the references how could verify the work experience, particularly for earlier projects, have either retired or cannot be located for a variety of reasons. Will the Crown establish an upset limit of three references per resource who are able to verify the work experience for each of the proposed resources?

Answer 43: No. The RFP will remain unchanged.
