AMENDMENT #006

The intent of this amendment is to answer potential bidder questions:

- Q1.** In 'bilingual annex b-1', in numerous places, the tender lists 'Support stand for table top unit'.
- Under **Electric Griddles** and **Gas Griddles**, each different size of stand has it's own listing. However, under **Electric Clamshell Griddle**, **Gas Clamshell Griddle**, **Electric Char-Broiler**, and **Gas Char-Broiler** multiple sizes of units are listed however only one listing is provided to submit a price for the various sizes of stands. Different sizes of stands are different prices.
 - How should stands be priced?
 - Can a revision of 'bilingual annex b-1' be provided, listing the different sizes of stands for those units?
- A1.** Annex B1 has been amended to provide individual pricing per stand size.
- Q2.** **Electric Convection Oven** and **Gas Convection Oven** (both single and double) are supported by legs, therefore no stand is required. Should that pricing line be left blank?
- A2.** Those lines has been removed.
- Q3.** The RFP Pricing Basis (Annex b-1) makes it mandatory to provide a unit price for all items labelled "M". It also makes provision for the inclusion of unit prices for the rated requirements for the piece of equipment. Where the rated requirement is included in the standard unit pricing for a piece of equipment, is an entry of \$0.00 acceptable for that rated requirement.
- A3.** It is acceptable to have an entry of \$0.00 for rated requirement.
- Q4.** Can you also confirm it applies where a mandatory line item is included in the unit price for the equipment?
- A4.** Yes it also applies where a Mandatory line item is included in the unit price for the equipment.
- Q5.** In 'annex a-1 specifications attachments', for the Broiler on Page 27 of 70, under 'Configuration', it states, "the gas unit must be available as free-standing or table top...". In 'bilingual annex b-1', under 'Gas Char-Broiler' (Lines 248-256), the various sizes of char-broilers are described as "free-standing".
- Char-broilers are typically considered countertop equipment as they can be placed on a counter (or table) along with other pieces of countertop equipment. However, as countertop equipment, they can also be placed individually on a stand (the stand being the same length and width of the broiler). Equipment when on a stand would be considered 'free-standing'.
- Can you please clarify if the char-broilers on Lines 248-255 of 'bilingual annex b-1' are to be priced including the stand OR without the stand? As the stand is itemized separately, it would suggest the char-broiler should be priced without stand however 'free-standing' implies it should be priced including the stand.
- A5.** Char Broiler are to be priced without stand and stand to be priced as per bilingual annex b-1.
- Q6.** The RFP requires delivery of items to 5 Regions in Canada and a total of 31 destinations. The bidder is required to provide prices on the XLS file provided but there is no provision for pricing breakdown by region or location. Delivery costs of items will vary tremendously between regions and locations. Can you clarify if we should provide one bid per item with all prices included per region or location?

A6. Delivery is to be included in the all-inclusive unit price, applicable to any/each region.

Q7. Just wanted to ask you a quick question on the induction units. I see that you requested a much higher wattage than usually supplied. Can you confirm that for me? We offer 1400-1800 anything higher is done on a 208/240AC. If that's ok with you. I just want to make sure so we can submit our units due to your specs otherwise an amendment needs to be done for a 120AC with lower wattage. Ours go as follows.

1440-1800 Watts 120AC 5-15P plug
2900-3400 Watts 208/240AC 6-20/6-30P plug

A7. You can submit your units as 208/240AC.

M2 – Remove – Fiberglass or full insulation (Induction units cannot be insulated)
M2 – Remove – Protective knob guard (Induction units can only be digital OR analog, not both).
M3 – Remove - Temperature marks on knob (Induction units can only be digital OR analog, not both).

M1 - Change platform sizes to 6-3/8" x 6-1/2" to a maximum of 9.5" x 10.75"
(There are NO 32oz. scales with 1/4oz. increments with an 8.5" x 8.5" platform)

Q8.F. Portion Scales – Annex B-1 & Annex A-1

Change - 32oz. by 1/4 oz. to 32 oz. by 1/8th oz. to accommodate the 30 deg. rotating dial spec criteria.

M1 – Change Porcelain to China – Porcelain cannot be vitrified
