**Q1.) Which party is responsible for closing out electrical and HVAC systems during the remediation?**

A1.) The Contractor is responsible for closing out the systems as required, and for re-establishing those systems upon completion of the rodent waste cleanup work. Relevant sections of the Specifications include (but are not necessarily limited to):

- a. WORK RESTRICTIONS, section 1.5;
- b. HEALTH AND SAFETY REQUIREMENTS, section 1.15 and section 1.6;
- c. GENERAL INSTRUCTIONS, section 8.1;
- d. TEMPORARY UTILITIES, section 1.3 and sections 1.5 through 1.7; and
- e. RODENT CONTAMINATION REMOVAL PROCEDURES, section 2.5.

**Q2.) Will the Contractor be required to provide its own power sources and power bars?**

A2.) The Contractor may use the buildings' existing 110 volt/15 amp electrical power and lighting, but must provide its own electrical extension and power cords, portable lights etc. Relevant sections of the Specifications include (but are not necessarily limited to):

- a. GENERAL INSTRUCTIONS, section 8.2
- b. SUMMARY OF WORK, section 1.5

**Q3.) Is the secondary office in the old Commercial Area warehouse part of the abatement area?**

A3.) The secondary office in the old Commercial Area warehouse is not included in the area for abatement.

All other terms and conditions remain unchanged.
