1. QUESTIONS AND ANSWERS

Q1: Could you please advise if the location will be able to accommodate a 53 ft trailer? If not, what is the maximum truck size?

A1: The maximum size truck for the loading dock is a 53' but we are unable to close the overhead doors. With large shipments, especially in mid-winter, drivers unhook and park outside while the truck is unloaded.

Q2: Could you please send the CAD drawing?

A2: The CAD drawing has been uploaded separately.

Q3: We would like to request an extension for this bid.

A3: The closing date has been extended until December 16, 2016.

Q4: The bid calls for panels only. Are these going to be used around existing furniture? Will there be a future request for panel mounted desking to be put into these panels? Just want to clarify as there is a significant amount of panels required, but no desking.

A4: This requirement is for panels only. There will not be a future request for panel mounted desking.
