Solicitation Amendment No. 004

This solicitation is hereby amended to provide the following questions and answers:

Question 2:

In regards to training there is some ambiguity in the solicitation document. In different parts of the document, training is stipulated as the responsibility of the successful contractor while in other parts of the document, most notably in the Annex C - Basis of Payment, that the training (if required) will be provided by RCMP (at the top of the document pages 14/27-19/27). This is a significant cost factor related to the Regional Individual Standing Offer (RISO) which needs to be clarified in order to effectively evaluate the cost factors associated with providing a competitive bid for the services requested for the RISO. Any assistance in clarifying this uncertainty would be greatly appreciated.

Answer 2:

In Annex C Basis of Payment

DELETE all references of:

Detention Guards (Training (if required) provided by RCMP); and

INSERT:

Detention Guards (Training (if required) provided by the **Offeror**).

Question 3:

Reference: Annex E – Mandatory Requirements, 5. Experience: A minimum of one example must highlight experience providing services in remote, isolated and rural communities. Clients can include municipal police services, Canada Border Services Agency or the RCMP. Does the Canadian Air Transport Security Authority (CATSA) qualify as an acceptable reference?

Answer 3:

It would **not** be an acceptable reference to demonstrate a minimum of five (5) years' experience providing services that meet **similar services** (as described in the SOW) to law enforcement agencies ("Clients"). The services are not a like duty as far as the role performed and being requested. They are doing airport screening which is significantly different then providing guarding of prisoners (unless they have an expanded role of which we are not aware, they have no powers of arrest or detention). The responsibilities are very different.

The Canadian Air Transport Security Authority (CATSA) **would qualify as an acceptable** reference to demonstrate services provided in a **remote or isolated area**.
