This amendment 002 is raised to answer questions received from industry as follows:

Q.1: The height range specified in the tender for the electric tables is 22.5"-44.5" high. Since this tender is for bases only, does the height range apply to the base only, meaning when a 1" top is added the table range is 23.5"-45.5", or does the height assume a 1" top has been added to meet these dimensions giving the actual 22.5"-44.5" range and the base only dimension would be 21.5"-43.5".

A.1: The height assumes a 1" top has been added to meet these dimensions. The actual 22.5"-44.5" range of the base with top, and the base only dimension would be 21.5"-43.5".

Q.2: Where can you find information regarding the CAN/CGSB-04.227-2008 standard?
