Amend/revise the Standard Contract Documents as follows:

Contractor Questions

Question:

Will EOR will accept bolted web connections for the beam to beam moment connections?

Response:

All moment connections for beams below the building would conflict with the base plate connection to the aluminum columns. These will need to remain as welded connections. The remaining three moment connections below the concrete deck can be bolted.

Question:

For the tenant meter, does this have to be a revenue Canada approved meter?

Response:

A non-approved meter is acceptable.

Question:

For the 90A breaker to be installed in the Main Hydro cabinet, is it possible to supply the current manufacture/type?

Response:

No information is available on the Hydro panel. Assume 22ka interrupting.

Question:

Addendum E01, specifies contractor to provide patch panels in network cabinet, for the fiber, is it going to be a fusion splice termination or a mechanical termination?

Response:

Refer to the "Statement of Work" referenced in addendum 1 and included in addendum 2.

Question:

Suppliers have come back requesting specs and more information for the communication cabinets?

Response:

Refer to the "Statement of Work" referenced in addendum 1 and included in addendum 2.

Question:

Just a clarification that there will be no fire protection not even 120V smoke detectors?

Response:

Smoke detectors and fire alarm to be added. See electrical below.

ELECTRICAL

Add the following to electrical work:

Security Alarm System: Provide a 6 zone panel c/w battery , two key pads [two land side doors] two smoke alarms [along corridor] , door contacts on three exterior doors, two motion detectors and exterior alarm and strobe.
Power from Panel B . Wire to comms panel.
