This amendment is raised to 1) incorporate changes to the following sections of the RFSO: Appendix B – Price Proposal Form; and 2) provide responses to Requests for Clarification.

1) **Revisions to Appendix B – Price Proposal Form**

Proponents are hereby instructed to:

2) **Requests for Clarification**

Q1: PRICE PROPOSAL, Laboratory Services (page 95 of 102)

2.1 Standard Proctor (6in. Test, total 6 tests) – is the “Cost Per Test” for a single test or for a total of 6 tests?

A1: Under cost per test; quote price for six (6) tests. Refer to 1) Appendix B – Price Proposal Form – Revision 1 above.

Q2: PRICE PROPOSAL, Laboratory Services (page 95 of 102)

2.5 Compressive Strength Tests and Reports (assume 10 test, standard cast cylinder, field report and report). Concrete testing is typically carried out in sets of 3 or 4 cylinders. Does the 10 tests identified indicate that a total of 10 cylinders for testing are to be included in the Cost per Report?

A2: Under cost per report; quote price for ten (10) compressive strength test reports. Each test report to comprise of 3 cylinders. Refer to 1) Appendix B – Price Proposal – Revision 1 above.

Q3: Page 94 of 102, Appendix B, in Number 5 the wording “There must be neither no \$0 value nor NIL value” appears to have a double negative. Please provide correct wording.

A3: To clarify, Proponents must provide a Fixed Hourly Rate for each Category of Personnel and a Unit Price for each Category of Service. A \$0 value or NIL value must not appear in Price Proposal. Failure to insert an hourly rate or unit price for each category of personnel/service will render your proposal non-responsive.

Q4: Page 95 of 102, Item 2.5 states: “(Assume 10 test, standard cast cylinder, field report and report)” Should this say 10 tests? Is this a cost per cylinder or cost per set of cylinders?

A4: Refer to A2.

Q5: Page 95 of 102, Item 2.7: Is this a gradation of combined aggregates from the asphalt plant or an asphalt extraction and gradation?

A5: It is asphalt extraction and gradation.

Q6: Page 95 of 102, Item 3.0 Drilling (Rig) Mobilization and Rental Charges. Drill rig mobilization is normally charged per kilometre, not as a cost per day. Please clarify.

A6: Refer to 1) Appendix B – Price Proposal – Revision 1 above.

Q7: Price Proposal – Section D Equipment Rental: Laboratory Services – Line Item 3.0 – Drilling (Rig) Mobilization and Rental Charges

Can you please confirm that the Cost per Day is based on a standard 8hr day. In addition, mobilization fees will vary greatly based on assignment location. Can mobilization be provided on a per- assignment basis?

A7: A day is eight (8) hours of a week day. Refer to 1) Appendix B – Price Proposal – Revision 1 above.

Q8 : Price Proposal – Section B Concrete: Laboratory Services – Line Item 2.5 – Compressive Strength Tests and Reports

Can you please confirm that the Unit Price “Cost per Report” is for the laboratory compressive strength test and reporting per concrete cylinder (The description includes the assumption for 10 tests and a field report).

A8: Refer to A2.

All other terms and conditions remain the same.

The hourly rate provided must be equal to or greater than the hourly rate provided for the position listed below it. For example, if the firm does not have an Intermediate Personnel, the hourly rate provided must be equal to or greater than the hourly rate provided for the Junior Personnel. **There must be neither \$0 value nor NIL value.
