## **AMENDMENT 004 TO SOLICITATION F1782-16C752/A**

### **Revision 004:**

Replace Article 1-2.6 (Sourcing Strategy) in its entirety with the following text:

#### **"6. Sourcing Strategy**

The sourcing strategy related to this procurement will be limited to suppliers in the Area of Origin of the vessel (Western Canada), in accordance with the PWGSC Supply Manual Article 3.170.10(a). This procurement is subject to AIT and is exempt from NAFTA [see Chapter 10, Annex 1001.2b, paragraph 1 (a)] and from the WTO-AGP (see Annex 4).".

### **Revision 005:**

In Article 6.13 (Vessel Refit, Repair and Docking - Cost),  
Replace the title "Vessel Refit, Repair and Docking - Cost"

### **Revision 006:**
