#### **#1. Under: PART 4 - EVALUATION PROCEDURES AND BASIS OF SELECTION**

##### **#1a. Within: 4.1.2.2 Point Rated Financial Criteria – delete in its entirety & insert:**

**a.** The Offeror should address each point rated criteria listed in Annex 1 to Part 4 under Major Equipment and Minor Equipment.

For each piece of equipment that includes point rated criteria, one point obtained will be equivalent to a 1 percent deduction applied against each unit price (for evaluation purposes only).

##### **#1b. Within: 4.1.1.3 Evaluation of Price – delete in its entirety & insert:**

#### **4.1.3 Evaluation of Price**

a) In the event that an Offeror does not provide a unit price for any item that is not listed as “M” in Annex B-1, Pricing Bases “A”, PWGSC will for evaluation purposes only, remove that item from all Offers and that item will be eliminated from the evaluation process.

b) SACC Manual Clause M0220T (2016-01-28), Evaluation of Price

c) The extended prices of all items in Pricing Basis “A” and markup percentage in Pricing Basis “B” will be calculated by multiplying the estimated usage figures by the Offeror’s unit prices to calculate the extended pricing for each line item.

d) The extended prices will be added together to calculate the Offeror’s evaluated price.
