INSERT: vi) Landing Fee: Will apply to each landing made pursuant to a request by PACC and return to base after completion of work.

6. What is the anticipated award date of the contract?

Answer: February 2017

10. Can past history/forecast data on the number of trips by community be provided?

Answer: The following is provided for information. It does not infer a guarantee. Approximately 1000 flights are anticipated in the coming year.

13. Referring to page 36 article 2. Application of Rates and Charges, please provide further clarification on the definition of "Airport Charges" (billable) and "Miscellaneous Charges" (non-billable).

Answer: Airport fees may be charged back to Canada/MCRHR under the contract at cost (no mark-up). Other miscellaneous charges (including, but not limited to ground handling and de-icing) are the sole responsibility of the Contractor.

Additional Questions / Answers

1. The requirement is to have a company with experience providing full air medical evacuation services not just providing other medical services?

Answer: Yes, it's a mandatory requirement for the Bidder to have provided air medevac services 2 years within the past 5 years.

2. Does rotary have to be available 365 days, 24 hours a day, 7 days a week or just seasonally such as spring and summer because of remote access it may possibly be needed for?

Answer: Yes the rotary has to be available 365/24/7, as there is a possibility of pick up in remote locations that would not be accessible by floats or skis.

3. If a bid doesn't meet the mandatory requirement will it be rejected automatically?

Answer: Each mandatory criteria is evaluated on a pass/fail basis. Each mandatory must be met or the bid will be set aside if it missed one or more of the mandatories.

4. Is the maximum monthly retainer fee of \$50K a mandatory requirement?

Answer: The Basis of Payment indicates that the maximum monthly budget for the retainer fee is \$50K per month. It's a mandatory requirement to not to exceed that amount.

5. The RFP mentions that the aircraft is going to operate out of 3000 feet of asphalt or greater and/or 3500 feet of gravel and turf, is that implying that the airports that are less than 3500 feet of gravel and turf are going to be used by all aircraft or what will fill that void?

Answer: That requirement is for the bidder to have their primary base location at an airstrip that will meet that requirement.

6. Referring to the Basis of Payment terminology, landing charges by positioning, do you mean where the patient is located or positioning to the home base?

Answer: Refer to solicitation modifications.

7. Will the medical crew be transported to the Health Centre to pick up patient or will the patient be meeting at the airstrip? Are they transferring care at each location?

Answer: It depends on the community and on the medical condition of the patient. The ground crew, separate from the contract arranged by PACC, will pick up the patient at the destination.

8. Is there a deadline for submitting questions?

Answer: Questions are to be submit no later than five business days prior to the bid closing date which is December 22, 2016 at 2 pm CST.

9. Referring to mandatory criteria M4, can this requirement be met through air charter experience in combination with paramedical ground service experience?

Answer: No. It is mandatory to have 2 years of air medical evacuation service experience to meet the complex care needs included in this RFP.

10. Why was the previous RFP for this service cancelled? What was the reasoning behind this decision?

Answer: It was determined that the scope of work in the /A tender did not properly reflect the needs of Health Canada and the Mamawetan Churchill River and Keewatin Yatthe Health Regions. The /B RFP has modified the requested aircraft model (primary, secondary, back-up, rotary). Accordingly, the Basis of Payment has been modified to reflect these changes. It is also noted that Appendix 1 has been modified.
