PART 1 - GENERAL INFORMATION

1.1 Requirement

The Work to be performed is detailed under Article 6.2 of the resulting contract clauses.

1.2 Debriefings

Bidders may request a debriefing on the results of the bid solicitation process. Bidders should make the request to the Contracting Authority within 15 working days from receipt of the results of the bid solicitation process. The debriefing may be in writing, by telephone or in person.

1.3 Trade Agreements

"The requirement is subject to the provisions of the Agreement on Internal Trade (AIT)."

PART 2 - BIDDER INSTRUCTIONS

2.1 Standard Instructions, Clauses and Conditions

All instructions, clauses and conditions identified in the bid solicitation by number, date and title are set out in the *Standard Acquisition Clauses and Conditions Manual* (<https://buyandsell.gc.ca/policy-and-guidelines/standard-acquisition-clauses-and-conditions-manual>) issued by Public Works and Government Services Canada.

Bidders who submit a bid agree to be bound by the instructions, clauses and conditions of the bid solicitation and accept the clauses and conditions of the resulting contract.

The 2003 (2016-04-04) Standard Instructions - Goods or Services - Competitive Requirements, are incorporated by reference into and form part of the bid solicitation.

2.2 Submission of Bids

Bids must be submitted only to Public Works and Government Services Canada (PWGSC) Bid Receiving Unit by the date, time and place indicated on page 1 of the bid solicitation.

2.3 Former Public Servant

Contracts awarded to former public servants (FPS) in receipt of a pension or of a lump sum payment must bear the closest public scrutiny, and reflect fairness in the spending of public funds. In order to comply with Treasury Board policies and directives on contracts awarded to FPSs, bidders must provide the information required below before contract award. If the answer to the questions and, as applicable the information required have not been received by the time the evaluation of bids is completed, Canada will inform the Bidder of a time frame within which to provide the information. Failure to comply with Canada's request and meet the requirement within the prescribed time frame will render the bid non-responsive.

Definitions

For the purposes of this clause, "former public servant" is any former member of a department as defined in the *Financial Administration Act*, R.S., 1985, c. F-11, a former member of the Canadian Armed Forces or a former member of the Royal Canadian Mounted Police. A former public servant may be:

- a. an individual;
- b. an individual who has incorporated;

- c. a partnership made of former public servants; or
- d. a sole proprietorship or entity where the affected individual has a controlling or major interest in the entity.

"lump sum payment period" means the period measured in weeks of salary, for which payment has been made to facilitate the transition to retirement or to other employment as a result of the implementation of various programs to reduce the size of the Public Service. The lump sum payment period does not include the period of severance pay, which is measured in a like manner.

"pension" means a pension or annual allowance paid under the *Public Service Superannuation Act* (PSSA), R.S., 1985, c. P-36, and any increases paid pursuant to the *Supplementary Retirement Benefits Act*, R.S., 1985, c. S-24 as it affects the PSSA. It does not include pensions payable pursuant to the *Canadian Forces Superannuation Act*, R.S., 1985, c. C-17, the *Defence Services Pension Continuation Act*, 1970, c. D-3, the *Royal Canadian Mounted Police Pension Continuation Act*, 1970, c. R-10, and the *Royal Canadian Mounted Police Superannuation Act*, R.S., 1985, c. R-11, the *Members of Parliament Retiring Allowances Act*, R.S. 1985, c. M-5, and that portion of pension payable to the *Canada Pension Plan Act*, R.S., 1985, c. C-8.

Former Public Servant in Receipt of a Pension

2.4 Enquiries - Bid Solicitation

All enquiries must be submitted in writing to the Contracting Authority no later than seven (7) calendar days before the bid closing date. Enquiries received after that time may not be answered.

Bidders should reference as accurately as possible the numbered item of the bid solicitation to which the enquiry relates. Care should be taken by Bidders to explain each question in sufficient detail in order to enable Canada to provide an accurate answer. Technical enquiries that are of a proprietary nature must be clearly marked "proprietary" at each relevant item. Items identified as "proprietary" will be treated as such except where Canada determines that the enquiry is not of a proprietary nature. Canada may edit the question(s) or may request that the Bidder do so, so that the proprietary nature of the question(s) is eliminated, and the enquiry can be answered to all Bidders. Enquiries not submitted in a form that can be distributed to all Bidders may not be answered by Canada.

2.5 Applicable Laws

Any resulting contract must be interpreted and governed, and the relations between the parties determined, by the laws in force in Ontario.

Bidders may, at their discretion, substitute the applicable laws of a Canadian province or territory of their choice without affecting the validity of their bid, by deleting the name of the Canadian province or territory specified and inserting the name of the Canadian province or territory of their choice. If no change is made, it acknowledges that the applicable laws specified are acceptable to the Bidders.

PART 3 - BID PREPARATION INSTRUCTIONS

3.1 Bid Preparation Instructions

Canada requests that Bidders provide their bid in separately bound sections as follows:

Section I: Financial Bid (1 hard copy)

Section II: Certifications (1 hard copy)

Prices must appear in the financial bid only. No prices must be indicated in any other section of the bid.

Canada requests that Bidders follow the format instructions described below in the preparation of their bid:

- (a) use 8.5 x 11 inch (216 mm x 279 mm) paper;
- (b) use a numbering system that corresponds to the bid solicitation.

In April 2006, Canada issued a policy directing federal departments and agencies to take the necessary steps to incorporate environmental considerations into the procurement process [Policy on Green Procurement](http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html) (<http://www.tpsgc-pwgsc.gc.ca/ecologisation-greening/achats-procurement/politique-policy-eng.html>). To assist Canada in reaching its objectives, Bidders should:

Section I: Financial Bid

Bidders must submit their financial bid in accordance with the Basis of Payment. The total amount of Applicable Taxes must be shown separately.

3.1.1 Electronic Payment of Invoices – Bid

Failure to comply and to cooperate with any request or requirement imposed by the Contracting Authority will render the bid non-responsive or constitute a default under the Contract.

5.1 Certifications Required with the Bid

ANNEX "A"

REQUIREMENT

1. INTRODUCTION

1.1. Scope

This Statement of Requirement (SOR) will cover the materiel required for the completion of fifteen bush clearance kits. This will include one (1) chainsaw, brushcutter, helmet, and chaps per kit. It will identify the specifications of each piece of equipment, deliverables, delivery requirements, warranty information, and technical authority information.

2. SPECIFICATIONS and DELIVERABLES

2.1. General

1 RCR will require the provision of fifteen (15) kits that will consist of one (1) each of the items indicated in section 1.3. Specific technical requirements for each item are identified in the following paragraphs of this section.

2.2. Chainsaw Specifications and Requirement

The provision of fifteen (15) chainsaws is required. The minimum technical specifications are as follows:

2.2.1. Engine Specifications:

2.2.1.1. Power Output – 6.5 Horsepower (Hp) and 4.8 Kilowatts (Kw)

2.2.1.2. Power Speed – Capability of 9,600 rotations per minute (rpm)

2.2.1.3. Fuel Tank Volume – Minimum 0.9 Litres (L)

2.2.1.4. Idling Speed – Capability of 2,700 rpm or greater

2.2.1.5. Torque – Capability of 9,600 rpm

2.2.2. Lubricant Specifications:

2.2.2.1. Oil Pump Type – Automatic

2.2.3. Cutting Equipment Specifications:

2.2.3.1. Chain (blade) length of 36 inches

2.2.3.2. Chain Pitch – 3/8 inch

2.2.3.3. Minimum Bar Length of 18 inches

2.2.3.4. Chain Speed of minimum 20 metres per second

2.2.4. Miscellaneous Specifications:

2.2.4.1. Weight of entire chainsaw not to exceed 30 pounds (lbs)

2.3. Brush Cutter Specifications and Requirement

The provision of fifteen (15) brush cutters is required. The minimum technical specifications are as follows:

2.3.1. Engine Specifications:

2.3.1.1. Power Output – 1.9 Hp and 1.4 Kw

2.3.1.2. Power Speed – Capability of 8,400 rpm

2.3.1.3. Fuel Tank Volume – Minimum 0.6 L

2.3.1.4. Idling Speed – Capability of 2,500 rpm or greater

2.3.1.5. Engagement Speed – Capability of 3,800 rpm

2.3.2. Cutting Equipment Specifications:

2.2.3.1. Capability for multiple blades to be attached including a trimmer head, grass blade, or saw blade.

2.3.3. Miscellaneous Specifications:

2.2.4.1. Weight of entire bush cutter not to exceed 20 lbs.

2.4 Safety Helmet System Specifications and Requirement

The provision of fifteen (15) safety helmet systems, specifically designed for outdoor use with chainsaws, is required. The minimum technical specifications are as follows:

2.4.1 High-visibility orange colour for clear identification

2.4.2. Helmet must at a minimum meet Canadian Standards Association safety requirements for Z94.1-2003 Class G-E Standards

2.4.3. Include a face screen for protection from debris (plastic or mesh is acceptable)

2.4.4. Minimum 25 Decibel (Db) Noise Reduction Rating (NRR) hearing protection attached with the helmet

2.4.5. Adjustable backing on the helmet for various adult head sizes

2.5 Chainsaw Chaps Specifications and Requirement

The provision of fifteen (15) protective chap leggings is required. The minimal technical specifications are as follows:

2.5.1. Made with a Denier Outer Shell

2.5.2. 36 to 38 inches in length

2.5.3. Layered Kev-Malimot protection

2.5.4. Must meet American Society for Testing and Materials safety standard F1897 for protective equipment utilized by chainsaw operators.

3. EFFECTIVENESS REQUIREMENTS

3.1. Delivery
