Amendment 002

This amendment is raised to publish questions and answers.

Q2. *In preparation of our response, we would appreciate some clarity around what Protected B information are we expected to safeguard in regards to this contract. If the RFP for PAD requires Protected B level clearance, it is our understanding that further information about our locations and more stringent security controls may be asked of us. It is important for us to evaluate this additional ask in order to assess the scope of this RFP.*

As we understand, the PAD file will only contain Account holder name, banking information and dollar value of pre-authorized debit. It is our understanding that Protected B information is classified as being of a sensitive nature such as: home address, social insurance number, driver's license etc. the type of information that could result in identity theft. Therefore, why would the PAD file not be classified as Protected A? Understanding the difference between Protected A and Protected B levels would clarify this security requirement.

A2. Please note that the aggregation of personal and financial information (name, amount, bank account information) transmitted within the PAD file constitutes Protected B level information.

All other terms and conditions remain unchanged.
