The purpose of this amendment is to answer questions pertaining to this solicitation.

Questions and Answers:

Question 1:

Can you explain the reason for cancelling 35035-165059/A superseding it with this request and/or the difference between the two RFPs?

Response 1:

The Privy Council Office has determined that there has been a significant change in the scope of the requirement. Notably, the ratio of samples have been adjusted so that it accurately reflects current behavior with respect to telephone usage in order to minimize any potential coverage error.

Additionally, there were some scoping issues with the Statement of Work leading to ambiguity in how data collection could be conducted. Revisions have been made throughout the document to address these issues.

Please note that it is the Bidder's responsibility to ensure that they review the entire document and respond accordingly.
