AMENDMENT #2

This amendment is put in place to issue the second set of questions and answers.

QUESTIONS AND ANSWERS

Question #2: Will Canada amend the RFP to ensure that the procurement process, and the Clauses and Conditions of the NeMO solicitation comply with Canada's obligations under the CETA agreement as it relates to Earth observation procurements?

Answer #2: We are not authorized to amend the RFP as requested. Until the CETA is ratified and takes full effect, Canada is not legally bound by this agreement, nor are European countries. Our current procurement policies therefore remain fully applicable. In this particular case, with the CSA currently being exempted from all Trade Agreements, the Canadian Content Policy will continue to apply to this procurement. The Canadian Content Policy is mandated by the government of Canada, therefore, PSPC must apply the Policy as set out in the Supply Manual.

Question 3: Will Canada grant an exemption to European bidders regarding the requirement in the solicitation which conditionally limits the NeMO procurement to Canadian services? In other words, will Canada exempt European bids from the risk that they will be eliminated from the evaluation process should two or more bids with a Canadian Content certification be submitted?

Answer 3: Until the CETA is ratified, PSPC must apply the CCP in accordance with the mandated requirement of the Government of Canada.

Question 4: Will Canada eliminate the reference to SACC Manual clause A3050T (2014-11-27) Canadian Content Definition from the NeMO solicitation to ensure there is consistency in the procurement policies, processes and selection criteria used on CSA Concept Study RFP's?

Answer 4: As per above, because PSPC does not have the authority to change the CCP, we cannot eliminate the reference to SACC Manual clause A3050T (2014-11-27) Canadian Content Definition from the NeMO solicitation.

Question 5: If Canada will not eliminate the reference to SACC Manual clause A3050T (2014-11-27) Canadian Content Definition will it reduce the Canadian content requirement from 80% to not more than 50% to be consistent with other recent Government R&D solicitations and create opportunities for Canadian industry?

Answer 5: As previously indicated, PSPC does not have the authority to alter the Canadian Content Policy, including the Canadian content requirement of 80%.
