This amendment 004 is raised to answer questions received from industry as well as to extend the bid closing date.

Q.6: Annex A - 6.1.2, requests a minimum height adjustment range from 22.5" to 44.5". Due to work surface thickness, when a table with this adjustment range is lowered to its lowest position, there will be no more than 21.5" clearance between the surface and the floor. Such a small clearance creates the opportunity for other surrounding furniture and users of average stature to be crushed. Most task chairs do not go low enough to work within a 21.5" clearance. Additionally, if you add keyboard trays you have an even smaller clearance remaining.

Our tables have a range of 25" to 50" (with work surface) which starts at a point where the 5th percentile North American seated elbow heights initiate and ends where European 95th % standing elbow heights end. Usually an external footrest is added with a chair to accommodate users who fall below the lowest requirements.

Given that our range accommodates the majority of users and avoid issues with surrounding furniture, please allow for a 25" to 50" range of adjustment.

A.6: We will not be changing our height requirements, as they were provided to us by our Ergonomic Team.

Q.7: Amendment 003 Q&A 5 states Delivery is to include the assembly of the bases. Will assembly be done on site? The size of the actual work surface size will needed to be given at time of assembly to determine length of the base.

A.7: Assembly of base only is required, on site. Bases will be stored until required. Our team will install them and adjust them according to surface length.

Q.8: Further to Amendment #003, Q&A#5 delivery is to include assembly of the bases. We have a couple additional questions/concerns: To be able to accommodate surfaces between 48" and 72" wide, these bases are adjustable – without knowing the width of surface to be installed, how are we to know the adjustment required? Also, the control box for the electrical needs to be mounted to the underside of the surface – are we to just leave the wires/control box hanging for future installation? Once assembled, are they to be left on the loading dock or to be placed elsewhere and levelled?

A.8: Our team will adjust the width as required at a later date.
Leave the wires/control box attached to the leg.
Bases will be placed elsewhere.
