**The following changes in the Tender Documents are effective IMMEDIATELY.
This addendum will form part of the Contract Documents**

Amend/revise the Standard Contract Documents as follows:

MODIFICATION TO THE WORK

1. Refer to Drawing G1.0 General Note 4 – Structural pad shall extend to the curb where the existing temporary generator is located. There should not be a gap.
2. Refer to Drawing E2.0 & Addendum 1 item 16 - Revise feeders from generator splitter to load bank and E-CDP to (4 #600MCM & #2 insulated ground in 103mm conduit or 2 parallel runs of (4 #3/0MCM and #4 insulated ground in 63mm conduit) All underground conductors shall be RWU). Contractor may transition from PVC to flexible cables for final connections at the generator.
3. Refer to Drawing E2.0 -- The breaker for the load bank shall be NEMA 3 rated.
4. Refer to Specification 26 32 10 Revision 1 – Cummins A026H213 battery charger shall be approved as equal to SAFT battery charger.

ADDITIONAL INFORMATION FOR CLARIFICATION

1. Refer to Drawing G1.0 – The intention is that the generator pad and the loadbank pad would be a single pad. These pads would be surrounded by a permanent louvered screen. Any reference to a fence or equipment screen is intended to be the same thing. Refer to G1.0 for acceptable manufacturers.
2. Refer to Drawing M1.0 & Addendum 1 Note 19 -- The existing fuel pump is to be replaced with a new fuel pump. Only one fuel pump is to be used in the project.
3. Refer to Addendum 1 Note 12-- The existing diesel fuel tank does not have a level indicator or leak alarm. Contractor shall provide new as required.
4. Refer to Drawing E2.0 -- The existing loadbank shall remain, and a new loadbank will be provided by contractor.
5. Refer to Addendum 1 – For clarification, the contractor shall establish a new contract with Cummins regarding the existing temporary generator. Since the generator is already on site, set-up costs would not be required. The contractor shall be responsible for all costs associated with the generator including maintenance, testing and removal.
