Replace 312333.01-3.6.3 with:
Excavate all Contaminated Material laterally and vertically to the uplands Property Line. Excavate all Contaminated Material laterally at surface to the marine or foreshore Property Line (approximately the High Water Mark) and to depth sloping inland at approximately 1 horizontal to 1 vertical. Leave a berm of insitu soil between the excavation and the ocean. Do not excavate below the High Water Mark on the foreshore.

All other terms and conditions remain unchanged.

Response to Questions:

Question 1: In Appendix B Geotechnical Foreshore Investigation 5.0 Comments – it states “The assessment and description of potential marine barrier options will be provided in a subsequent technical memorandum.” Can you confirm if this memorandum will be issued to us ?

Answer 1: As this solicitation is a design-build this technical memorandum was not completed.

Question 2: Placement of shoring: Excavation to happen to property line. Does this mean that the contractor has permission to place shoring just outside of property line, and excavate right to the property line? Or is the contractor to place shoring flush to the inside of property line and excavate to the shoring?

Answer 2: Shoring may be placed outside the excavation limits on adjacent property where that adjacent property is owned by Transport Canada. If the adjacent property is not owned by Transport Canada then any shoring must be placed on the property line.

Question 3: Upland Discharge: What is required to obtain Transport Canada's permission to discharge water to the upland sump? Permits? Standards/ guidelines?

Answer 3: For onsite discharge to the uplands Transport Canada property, no permits are required; however, discharge cannot impact Transport Canada property (eg erosion, silt), and would need to meet the more stringent of BC CSR and CCME groundwater standards.

Question 4: Stockpiling: Remediation soil storage/ stockpiling not permitted on Esquimalt FN Lands. Does TC have permission from Esquimalt FN to stockpile in the staging areas?

Answer 4: Yes, but the Contractor is responsible for ensuring stockpiling does not impact the underlying soil or water.

Question 5: Transfer/Interim Storage Facility: Definition does not require a permit for the facility. Confirm this is acceptable.

Answer 5: Onsite storage facilities do not require a permit. Offsite storage facilities are the responsibility of the Contractor.

Question 6: 01 11 00 requires mobilization within 10 days of award: Most critical submittals are required by then, but allow 10 working days for review... so what can we do upon mobilizing and awaiting review of key plans and procedures?

Answer 6: Mobilization cannot occur until critical submittals are reviewed. If the Submittals are complete review can be performed in 2 days.

Question 7: 01 41 00 1.3.1 then requires all approvals, permits, etc to be submitted at or prior to contract award (at least 10 days prior to mobilization). Please clarify what submittal are anticipated under this section.

Answer 7: It is the responsibility of the Contractor to determine and obtain all required approvals or permits.

Question 8: 01 52 00 clause 1.16.1 requires water for contaminated truck wash. Please confirm the water source to be used and what service is to be installed.

Answer 8: As per 011100-1.6.4.2, water is not available on Site. The Contractor is responsible for supplying water.

Question 9: Is all contamination to be removed along all Limits of Eastern Upland Remediation on Drawing 4?

Answer 9: No. Excavation of all contamination is required along the uplands remediation limits, as shown in the red dashed line on the Amended Drawing 4. Excavation of all contamination is not required along the marine/foreshore remediation limits, as shown in the black dashed line on the Amended Drawing 4. For the marine/foreshore remediation limits, excavation will start at the Property Line (which is approximately the High Water Mark) at surface, and slope at approximately 1:1 (depending on soil and tide conditions) inland from the Property Line. Thus there will be a wedge of contaminated fill remaining only along the marine/foreshore remediation limits.
