ADDENDUM #1

Questions Submitted to PWGSC

Question #1

As the work area is outside of the facility proper is there any special paper work required for our labours and subtrades to be on site? E.g.: criminal background' checks, etc.?

Answer to Question #1

All person's working on site are required to be security cleared thru CSC. CPIC Forms for criminal record check will be provided to contractor upon award. There is no cost to the contractor for this requirement.

Question #2

How much room is being allotted to spot a jobshack and C-Can?

Answer to Question #2

The Gravel pad, West of the new tank location has room to place 2 C-Cans side by side.

Question #3

Are we able to bring our vehicles directly to the work area and park them there, or do we need to offload and move vehicles back to parking lot? Spec says "Park vehicles outside perimeter fence in designated parking areas", but does that include company trucks containing tools and materials?

Answer to Question #3

You may park a couple of vehicles alongside the gravel pad (parallel) to curb without disrupting roadway. Closer parking can be accommodated for another 4-5 vehicles.

Question #4

As a time factor would all material and equipment be subject to inspection?

Answer to Question #4

Security inspection by CSC are not required for materials and equipment arriving to site.

Question #5

If existing tank level transmitter is Incompatible with new tank and requires modification or replacement this would be a change order?

Answer to Question #5

Yes, replacement or modifications to existing tank level transmitter will be handled as a change order (if required). This however should not be required.

Question #6

Water table and soil remediation were brought up. Do you require unit prices in case, or do we price project assuming all is good and treat as a change order if we run into issues?

Answer to Question #6

Price project assuming soil remediation and contaminated soil/water disposal is not required, if soil remediation and contaminated soil/water disposal is required these items will be treated as a change order.
