**AMENDMENT 005 SEEKS TO ANSWER QUESTIONS FROM POTENTIAL BIDDERS**

**Q1.** In addition to the continuous 48 hour closure of the bridge, please advise on how many night (9:30pm to 6:00am) bridge closures we are allowed.

**A1.** In addition to the continuous 48 hour closure of the bridge, a maximum of 20 night (9:30pm to 6:00am) bridge closures will be permitted. The contractor must assume that these closures may be scheduled by the Departmental Representative on any day of the week (weekdays/weekends or a combination of both); the bid price must accommodate all of the aforementioned scenarios. The Contractor must schedule his operations in such a manner that the duration of activities which prevent emergency vehicle crossing of the bridge are kept to an absolute minimum.

**All other terms and conditions remain unchanged.**
