Question 2:

In your RFP, it is stipulated that the supplier must hold a Designated Organization Verification (DOD) certificate, except XXX has never had to hold this certificate before, so we are not familiar with the process.

After contacting the Government of Canada's Customer Service Department, the first step in this process is to be sponsored by an authorized procurement officer. As the contracting authority for this project, you are authorized to sponsor our organization to initiate the security audit process.

Answer 2:

Organizations bidding on a Government of Canada or foreign government contract with security requirements must be sponsored by an approved source, such as the Contracting Authority, in order to be screened through the Contract Security Program.
