This amendment has been raised to answer questions from a supplier:

Questions and answers:

1. I know there are 3 locations indicated in the specification document but I was just wondering, what is the anticipated percentage breakdown of work required in each city?

It is very difficult to anticipate the work breakdown based on location. Red Deer's Cormack Armoury is very old and requires a lot of attention. The Cadet Camp just NW of Cochrane is a very busy place and requires unique renos and maintenance. Even though the majority of our buildings are situated in Calgary, they are newer and have gone through some upgrade renos in the recent past. So the best educated guess is an even 1/3 split based on the 3 locations, at this time.

2. What is the minimum call up that may be called up for this standing offer? I am trying to get a sense of work load and expectancy based on past work and experience?

The minimum call-up can be as low as \$120.00 for something like hanging a white or corkboard in an office and as high as \$60,000.00 for a renovation. If an emergency occurs, the max call up can be increased on a case by case basis. Emergency authorities would come into play, but is a very rare occurrence.
