#### **QUESTION AND ANSWER #2**

### Question #1

Please define "research instrument" as referenced from Page 4 (second paragraph) of Amendment #1.

#### Answer #1

As per the following sentence in the cited paragraph: The researcher will design either or both: a questionnaire to be sent to the laboratories; an in-depth interview guide. This is consistent with the identified task 4.3.

# **Question #2**

My understanding is that the interview/questionnaire is to be directed to the selected test labs, so what does it mean by "selection of interview/questionnaire subjects" as outlined on page 19 (Part 5 – R3) of the RFP? Is it requesting a proposal plan on how to select the best test lab(s) amongst a number of candidates, where a rough guideline (or detailed questionnaire) is needed for this screening process?

## Answer #2

The bidder is expected to demonstrate their ability to design the sampling frame of the laboratories that will be included in the study, both in Canada and in the U.S. It is up to the bidders to demonstrate their capacity in designing the sample in a concise and convincing manner. While the RFP states that "[t]he PA could assist the successful bidder with the list of laboratories in Canada, as well as share ideas for the questions that should be asked on the research instrument" (p. 11), it is expected that the bidders would have full ability to create the list of laboratories in Canada and the U.S. by themselves, as well as design the sample and demonstrate the capability of understanding the scope of work required to create the sample.

#### Question 3

Does this RFP require summary of any literature review on the topic of laboratory testing drugs, which also includes international perspective on the capacity of forensic labs to process drug-related samples?

#### **Answer 3**

A literature review is not required as part of the bid response. It is only required upon contract award. However, as part of Part 5, Evaluation Criteria and Selection Methodology, the Bidder is required to submit a work plan and approach and methodology detailing how work will be conducted should that Bidder be awarded the contract. How the work plan and approach and methodology will be evaluated is detailed further in the column entitled Points Breakdown.

# **Question 4**

How many pages / number of words would you suggest this bid to contain?



#### **QUESTION AND ANSWER #2**

#### **Answer 4**

Public Safety Canada will not suggest pages or number of words. There is no limit or minimum requirement. It is the Bidder's responsibility to fully demonstrate how they meet the requirements of the solicitation within their bid response.

# **Question 5**

The RFP for Solicitation No. 201704838 makes reference to the "DNA Forensic Laboratory Services Cost and Capacity Review" study by Government Consulting Services (2009).

This study does not appear to be available online.

Will the Client make a copy of this study available so that it can be considered in our response to the RFP?

## Answer 5

In 2009-10, the DNA Forensic Laboratory Services Cost and Capacity Review was finalized and shared with all FPT partners. However, it is currently not available on the PWSGC, PS, or Depository Services of Canada web site. Thus, Public Safety Canada is willing to share the report confidentially with bidders. To obtain a copy, Bidders may submit a written request directly to the Contracting Authority no later than bid closing. Bidders are to treat the report as property of the Crown and may only be used for the purposes of developing a bid for this project and, if the bid is successful, for completing the requirements of the RFP.
