1.	In the TTG Table in Annex G, Zone 15 has 3 separate lines with Different TTGS. Can you please correct it to have just 1 row for Zone 15?	Changes were made and a revised Annex G is published in its entirety as part of Amendment 001
2.	The previous history charts on pages 61 through 88 of Annex F only list city names, no countries. Can you please have the countries included?	Changes were made and a revised Annex F is published in its entirety as part of Amendment 001.
3.	In Annex F, it appears that there are also some domestic shipments listed. These should be removed.	Changes were made and a revised Annex F is published in its entirety as part of Amendment 001.
4.	Some of the charts in Annex F do not differentiate imports and exports, this should be done.	These tables will be further clarified at time of the issuance of the RFP.
5.	When generating the excel format of the past history (Annex F), can you please have origin city, origin country, destination city, and destination country listed in separate columns (for Canadian cities, the country can be the provinces)?	Information on the cities and countries is available in the revised Annex F, which is published in its entirety as part of Amendment 001 (see Q2). Industry may manipulate the information in order to analyse it.
6.	Clarification should be provided regarding whether the weights shown in the past history charts include or exclude the PMVs.	Changes were made and a revised Annex F is published in its entirety as part of Amendment 001 to indicate whether the weights include the PMVs.
