QUESTION 1

There is no planned visit in the tender documents but would it be possible to plan an on-site visit in order to analyze the premises and the current building?

ANSWER 1

With the exception of the inside of the reception building, the site is accessible and may be visited by the entrepreneurs. No formal visit is however planned.

QUESTION 2

The Work completion date is scheduled for May 5, 2017. However, there is some paving work jobs that needs to be done later due to procurement. Could you please clarify?

ANSWER 2
