## **Water Testing**

The Department of National Defence (DND), Canadian Forces Base (CFB) Borden, Borden, Ontario requires a contractor to supply all labour and materials to do water sample testing of potable water and non-potable water, recreational swimming pool water and hot tub water at CFB Borden.

The contractor must analyze and report results of the potable and non-potable water, recreational swimming pool water and hot tub water at (DND), (CFB) Borden, Ontario.

Water must be tested in accordance with Ontario Health requirements. In addition to the 27 weekly samples, as per Canadian Drinking Water Quality Guidelines (CDWQG) and Ontario Drinking Water Standard (ODWS), additional samples will be sent quarterly for testing for Nitrites/Nitrates, Chlorites/Chlorates, THMS, and HAAs and semi-annually for testing of Organics/Inorganics. Annual testing will occur for Lead, Radionuclides and PFC's.

The Laboratory must be registered with the Standards Council of Canada and must provide their Accreditation Number showing their registration and/or CALA accreditation.

**All samples will be collected by the DND Base staff.**
