SCOPE OF WORK / DELIVERABLES:

The scope of work consists of the furnishing of all plant, labour, equipment and material for this Mactaquac Biodiversity Facility exterior lighting upgrade at Kingsclear, NB. The project is to be completed in strict accordance with the specification and accompanying drawings, and subject to all terms and conditions of the Contract.

In general, work under this contract consists of, but will not necessary be limited to, the following:

1. Replacement of all exterior lighting with new LED fixtures as per drawings;
2. Installation of wall mounted and pole mounted fixtures; and
3. Reuse all existing wiring, circuits and controls.

FAMILIARIZATION WITH SITE:

Site visit is mandatory before tender closing. The site visit will occur over a one (2) day period. Contractors wishing to visit the site must contact by email the Senior Contracting Officer listed below.

Before submitting a bid, bidders need to attend the mandatory site visit at their own expense, to review and verify the form, nature, and extent of the work, materials needed for the completion of the work, the means of access to the site, severity, exposure, and uncertainty of weather, soil conditions, any accommodations they may require, and in general shall obtain all necessary information as to risks, contingencies, and other circumstances which may influence or affect their bid. No allowance shall be made subsequently in this connection on account or error or negligence to properly observe and determine the conditions that will apply.

MANDATORY REQUIREMENTS:
