This solicitation amendment No. 005 is raised to:

- 1) publish questions and answers that have been received in relation to this solicitation.

- 1) The following Question and Answer has been provided:

QUESTION 1:

"Please provide drawing for item no. 3 on tender – "Cone Tops". Alternately, confirm this is as detail 8-C on drawing # FA-3005? If so, are these five (5) extra per lot, in addition to those shown on drawings?"

ANSWER 1:

An alternate drawing for the Cone Tops is not available. The Cone Topes are to be built as shown on drawing # FA-3005 in Appendix 4 to Annex A. The Canadian Coast Guard requires only half of the buoys received to have cone tops. Therefore, each lot of 10 buoys requires only 5 cone tops.
