Questions and Answers

Q62 Can you please confirm for Section 1.1 Integrity Provisions – Declaration of Convicted Offences that if the Bidder has no convicted offences to declare, that there is no requirement to submit a declaration?

A52 The form must only be submitted when:

The Bidder, one of its affiliates or a proposed first-tier subcontractor has been charged with or convicted of a criminal offence in a country other than Canada that, to the best of the supplier's knowledge and belief, may be similar to one of the listed offences in the Ineligibility and Suspension Policy (the "Policy");

and/or

The Bidder is unable to provide one or more of the certifications required by the Integrity Clauses.

Q63 Can you please confirm what "Required Documentation" is required for Section 2.1? Previous Government of Canada solicitations, the Bidder is required to submit a list of the Directors and Officers of the company. Can you confirm if that is the required documentation?

A63 All bidders, regardless of their status under the policy, must submit the following information when participating in a procurement processor real property transaction:

- i. bidders that are corporate entities, including those bidding as joint ventures, must provide a complete list of the names of all current directors or, for a privately owned corporation, the names of the owners of the corporation;
- ii. bidders bidding as sole proprietors, including sole proprietors bidding as joint ventures, must provide a complete list of the names of all owners; or
- iii. bidders that are a partnership do not need to provide a list of names.

Bidders must, within 10 working days:

- Inform the contracting authority in writing of any changes affecting the list of names submitted further to section 17(a); or
- Inform the Registrar of Ineligibility and Suspension in writing, of any charge, conviction or other circumstance relevant to the Policy with respect to itself, its affiliates and its first-tier subcontractors; and
- Any change affecting the list of names submitted.
