Item 1 – Work End date for the CCGS Ile Sainte-Ours

The Work End date for the CCGS Ile Saint-Ours is postponed from April 1, 2017 to April 7, 2017.

Item 2 – Item 5.11.2 Drain installation starboard upper deck

Question 1:

The technical description of the work of item 5.11.2.3, it is required to verify the state of internal parts, such as: springs, etc. Can this be cancelled to avoid dismantling of all nearby electronic components?

Answer 1:

The requested work is to replace the sealing joint around the glass of the windows. All other work specified are cancelled and to remove of the specification.

Item 3 – Item 5.12.1 Complete (5-year) inspection starboard diesel propulsion engine & revision of transmissions

The work requested in the specification must all be performed, no matter how many running hours. Transport Canada is asking for these inspections after either a certain amount of running hours, or a certain time. In this case, time is up.

Item 4 – Item 5.12.2 Annual maintenance starboard main engine

As stated in the spec, requested work are the ones recommended by the manufacturer for an annual maintenance without excluding any extra work described in the document.

Item 5 – Item 5.13.1 Complete (8-year) inspection port generator diesel engine & revision of transmissions

The work requested in the specification must all be performed, no matter how many running hours. Transport Canada is asking for these inspections after either a certain amount of running hours, or a certain time. In this case, time is up.

Item 6 – Item 5.13.1, item F)

Question 2:

In Item 5.13.1.3 technical description in item F, it is required to submit new liners. To put on new liners it is necessary to take out the engine, because to install new liners it is necessary to install press fit and in addition it is necessary to plan the block.

Can we first take measurement and when measurement are acceptable by the Perkins representative it would not be necessary to replace the liners?

Item 9 – Item 6.11.3 Replacement of a pipe between the forward and aft tanks**Question 3:**

It is required for the compartment to be made gas free. Are the tanks requires it? Is there valves to isolate the tanks?

Answer 3:

Only if the Contractor plan to do hot work on the tank, for example; if a bracket has to be welded on the tank.

Question 4:

If the bilges are non-compliant, is it possible to treat this as 1379?

Answer 4:

If contractor consider bilges configuration not compliant, it will be his responsibility to demonstrate how the extra costs are induced.

Question 5:

Is it necessary to transfer the fuel into drums for both tanks? What is the quantity of fuel for each tanks?

Answer 5:

CCG will provide assistance if fuel transfer is needed to do the work.

Item 10 – Item 6.11.5 Floor replacement port galley and starboard washroom

The following requirements are added to the Technical Statement of Requirement:

- The access panels must be flush.
 - Aluminum panel will have a smooth surface and be covered by a grey vinyl layer.
 - Galvanic isolation joints between steel and aluminum are to be included in the submission.
 - A system to secure the panels must be installed to prevent vibration.

For the inspection of the davit it is required to change the brake bands. We need spectrum (drawing or plan) to bid.

Question 12:

What is the model of the window?

Answer 12:

Heated window, 1500 watts, dimension approx. 24" x 36".

Item 17 – Item 7.16.2 Potable water tanks

Question 13:

Will the Contractor have access to the last water quality report?

Answer 13:

The report will be supplied to the contractor who will win the contract

Question 14:

Is it possible for the ship to do the external pumping with its water systems at all time?

Answer 14:

Internal pumping systems are off for the winter. The required flushes of the tanks during the cleaning phase will have to be done by external means. The trial phase will have to be performed near end Work Period date where the internal pumping system will be put back in operation with the assistance of CCG.

Question 15:

Is it only the tanks to be super-chlorinated?

Answer 15:

Water distribution network must also be treated.

Question 16:

How many samples are required per tank?

Answer 16:

No information available. As per regulation.
