**Questions 1:**

Can you please clarify what is expected of offloading?

**Answer 1:**

Offloading includes moving the equipment from the truck to the loading dock, upon delivery to the final place in the lab for installation. There are pallet jacks and carts. The loading dock has a lift to offload large items off of trucks. Pricing must include all costs associated with complete delivery of the equipment.
