Appendix 001

Question 61

4.7.3. Post invitation to participate in the acceptance test, the bidder will have 10 (ten) days to configure their lab environment in accordance with the architecture proposed by SSC.

4.7.4. The bidder has a maximum 5 (five) days to demonstrate to SSC that they meet all the testing requirements.

Can the crown confirm that the Test Lab will be covered as part of the 30 day implementation window?

Answer 61

No, the lab used to perform the acceptance testing will not fall into the 30 day implementation window. This test will be conducted prior to any contract award. A contract will not be awarded should the bidder's solution not successfully demonstrate the test plan. The lab described in section (4.2 of the SOW) that is to be built for SSC will be included in the contract.

Question 62

Will the crown be responsible for the expenses incurred for the test lab?

Answer 62

In accordance with 4.7.3 the bidder will be hosting the lab environment for the acceptance test. The Crown will make use of the bidder's lab. The bidder will not be responsible to cover travel cost of SSC individuals to the test lab (4.7.2 of SOW). The bidder will be responsible to have the lab environment prepared and ready to demonstrate the acceptance test. The Crown and bidder will not have a contract in place at this time because the successful completion of the test plan is a requirement prior to contract award. Thus the Crown will not be responsible for expenses incurred for the acceptance test. The Crown will be responsible for costs related to section 4.2 of the SOW which involves the design, configuration and testing of the permanent lab environment meetings SSC's requirements.
