This RFP outlines in Part 7 - Resulting Contract Clauses, Section 7.5 - Security Requirement on Page 29 that (a) the Bidder must hold a Security Clearance at the level of SECRET and (b) the Proposed Personnel must hold a Security Clearance of either RELIABILITY STATUS, CONFIDENTIAL or SECRET.

However, within Annex C - Security Requirements Check List on Page 54, under Section B - Personnel (Supplier), 10 a) confirms that 'Personnel security screening level required' is SECRET.

Please clarify the Security Clearance required for each of the Resource Categories described in this RFP.

- (b) The Contractor personnel requiring access to PROTECTED/CLASSIFIED information, assets or sensitive work site(s) must EACH hold a valid personnel security screening at the level of SECRET, granted or approved by Cisd/PWGSC.
