### **Question 64**

We have noticed that there is a potential conflict in the above noted RFP. The issue relates to both of the pricing requirements for scanners.

Line 2 of the Purchased Items tab and Option 2 of the Optional Items tab refer to SOW 5.1.2 only. To price out the total number of scanners required we believe that the requirements of M2 and the associated clarifications in the Amendments need to be included as requirements of both items noted.

Can you please clarify.

### **Answer 64**

Both Annex A section 5.2.1 and the mandatory M2 apply to the initial contract period, plus any of responses to questions during the Question and Answer process.

The Crown will amend to add M2 to this requirement in pricing tables to avoid ambiguity or confusion. Please refer to Appendix 002 of this amendment.
