**Questions & Answers:**

Q15. A & B Typical Office, item C - Category 4 of the Workspaces Supply Arrangement is "Wood Veneer –Freestanding Products", not laminate. Either the items must be changed to Wood Veneer or the category changed to Cat. 1 "Interconnecting Panels and Freestanding Systems". If changed to Cat. 1 then the overall height of the hutch when stacked on low storage/credenza (low storage is a maximum of 31"h) must meet the Seated Privacy Height range of 50"-54". Please confirm.

**A15. CATEGORY 4 – WOOD VENEER WILL BE USED.**

Q16. A & B Typical Office, item C - Hutches with receding doors are not offered in Category 4, please confirm what item bidders should offer in lieu.

**A16. A "HIGH / ADD-ON UNIT" WITH CLOSED DOORS WILL BE USED IN LIEU.**

Q17. Group Typicals, Paneling - The SA Category 1a refers to "seated privacy height add-on" or "work surface privacy add-on" and does not indicate the height of the add-on. When Add-ons are stacked on base panels the overall heights must meet the privacy ranges (seated privacy 50"-54" & worksurface privacy 42"-48"). The SA does not indicated the heights of the add-ons. Please remove the height ranges from the descriptions for the add-ons, for example; Group 1 Item B, 6"-14"h.

**A17. DELETE THE HEIGHT RANGE STIPULATION FOR ADD-ONS. REFER TO THE SA FOR ALLOWABLE HEIGHTS.**

Q18. Group Typicals, Paneling - There are many contradictions between the height descriptions and the height ranges. For example, Group 1 item B indicates Seated Privacy Add-on and the range is 42"-48" in height, this is a contradiction as the SA Seated Privacy Height is 50"-54". Please correct these errors and therby confirm the heights required in all Group Paneling descriptions.

**A18. DELETE "SEATED PRIVACY ADD-ON".AND REPLACE WITH "WORKSURFACE PRIVACY ADD-ON."**

Q19. Group 2, Item C - Frameless Privacy Add-ons are found in Category 1b of the SA.

**A19. DELETE "WORKSURFACE PRIVACY ADD-ON" AND REPLACE WITH "PRIVACY SCREEN". REFER TO THE SA FOR ALLOWABLE HEIGHTS.**

Q20. Group Typicals, Paneling - where power elements are indicated to be required, suppliers offer elements which are capable of receiving Outlet Jacks such as the RJ45, but not the jacks themselves. Please confirm this standard practice is what PSPC is asking bidders to offer.

**A20. RJ45 JACKS ARE INDICATED.**

Q21. Group 2 Typical, item F - What configuration is required for the storage tower? Is a wardrobe required? File/File or Box/Box/File drawers? Closed or open storage shelves?

**A21. STORAGE COMPARTMENT WITHOUT A DOOR. SEE SA PAGE 46.**

Q22. Group 2 Typical, item H - The description is for a Box/File configuration, but the typical drawing shows a Box/Box/File, please confirm the type of pedestal required.

**A22. MOBILE BOX, BOX FILE.**

Q23. Group 3a, Item C - Frameless Privacy Add-ons are found in Category 1b of the SA.

**A23. REPLACE "WORKSURFACE PRIVACY ADD-ON" WITH "PRIVACY SCREEN". REMOVE "FRAMELESS" AND REFER TO THE SA FOR ALLOWABLE HEIGHTS.**

Q24. Group 3a, Items A, C & D - Electrical is located behind the credenza at the base of the panel and would not be accessible to the user. Please confirm if the power should be located above the worksurface height so that it is accessible.

**A24. COMPLY WITH ALL REQUIREMENTS OF THE SA.**

Q25. Groups 2, 3a & 3b - The typical 3Ds show an Accessory Element, please confirm that these are a requirement of the bid.

**A25. YES. "WORKSTATION ACCESSORIES" INDICATED ARE A REQUIREMENT OF THE BID.**

Q26. Group 4B – Workspace, Item C - Worksurface to be supported with metal end gable. No metal end gable is available on SA, please confirm laminate end gable is acceptable.

**A26. THE WORKSURFACE WITH END GABLE IS LAMINATE. DELETE THE WORD "METAL"**

Q27. Given the inconsistencies in products required vs what is available on the SA, kindly extend the closing date of the RFP

**A27. ALL PRODUCTS REQUIRED WILL COMPLY WITH THE SA.**

## **3 OFFICE GROUP 1 TO GROUP 6 (ALL OPEN OFFICES)**

### **All "Paneling" (base panels)**

- .1 **ADD** "With RJ45 Outlet (Multiple Jacks)" where not already specified. Refer to the SA for other power and cable requirements.
- .2 **DELETE** the height range "762mm-914mm (30"-36)".

### **All "Privacy Add-on" units**

- .3 **DELETE** the height range "152mm-356mm (6"-14")h".

### **All "Worksurface" Privacy Add-ons with "Frosted Glazing" finish**

- .4 **DELETE** "Worksurface Privacy Add-on" and **REPLACE** with "Privacy Screen (Category 1b)".
- .5 **DELETE** "Frameless".
- .6 **ADD** "Lower than or equal to Work Surface Height when combined with base panel". Except Group 6 (See item 7 below).

### **All Category 1b and Category 2 Worksurfaces (Desks and Tables)**

- .7 **DELETE** "Pre-finished Metal".

### **All Category 1b "Mobile Box File"**

- .8 **DELETE** "Mobile Box File" and replace with "Mobile Box, Box, File".

### **All "Workstation Accessories"**

- .9 **ADD** the words "or Plastic" after "Metal". Comply with the SA requirements.

**4 GROUP 1**

**Category 1b, Item C**

- .1 **DELETE** "Seated Privacy Add-on" and **REPLACE** with "Workplace Privacy Add-on".
- .2 **DELETE** "PrivacyPanel" and **REPLACE** with "Privacy Screen".
- .3 **DELETE** "Frameless".

**5 GROUP 2 AND GROUP 3 (a and b)**

**Category 1a, Item D**

- .1 **DELETE** "Worksurface Privacy Add-on" and **REPLACE** with "Seated Privacy Add-on".

**Category 1b, Item "Personal Storage Tower"**

- .1 **ADD** Storage compartment without a door. See SA page 46.

**6 GROUP 4 (a and b)**

**Category 1a, Item B**

- .1 **DELETE** "Worksurface Privacy Add-on" and **REPLACE** with "Seated Privacy Add-on".

**7 GROUP 6a AND GROUP 6b**

**Category 1a**

- .1 **DELETE** "Worksurface Privacy Add-on" and **REPLACE** with "Privacy Screen".
- .2 **ADD** "Seated Privacy Height".

All other Terms and Conditions remain unchanged.
