

Mechanical

1 GENERAL

- 1.1 This addendum is part of and shall be read jointly with the tender documents. In the case of contradiction, this document has precedence.

2 SCOPE

- 2.1 Question : *"Regarding terminal units with independent pressure (air valve), which division will be responsible for: Dismantling the Lon communication network of Phoenix valves and components of the existing dedicated network, router, etc.?"*
Answer : See Section 25 05 01 "EMCS: GENERAL REQUIREMENTS", article 1.9.7.
- 2.2 Question : *"For independent pressure units (air valve), which division will be responsible for: Change in the Lon server configuration for the remaining Phoenix valves?"*
Answer : See Section 25 05 01 "EMCS: GENERAL REQUIREMENTS", article 1.9.7.
- 2.3 Question : *"What type of signals will be sent by the independent pressure elements (air valves): communications or physical connection to the controllers?"*
Answer : The documents presented are performance specifications.
- 2.4 Question : *"Is an independent communication network required between the controllers of the independent pressure units (air valves)?"*
Answer : The documents presented are performance specifications.
- 2.5 Question : *"Will the signals connected physically (not by communication) be isolated from each other?"*
Answer : The documents presented are performance specifications.
- 2.6 Question : *"Is a 120 / 24Vac transformer required for each of the independent pressure units (air valve)?"*
Answer : See specific notes to plan M 35 / 36 issued in Addendum Pageau Morel NO.01.
- 2.7 Question : *"Who is responsible for the networking of the independent pressure units (air valve) in the event that an independent communication link is required?"*
Answer : See Section 25 05 01 "EMCS: GENERAL REQUIREMENTS", article 1.5.3.
- 2.8 Question : *"Who is responsible for the commissioning of the independent pressure units (air valve) in the event that an independent communication link is required?"*
Answer : See Section 25 01 11 "EMCS: START-UP, VERIFICATION AND COMMISSIONING".
Each control point must be tested.

QUESTIONS AND ANSWERS DURING BID:

1. On plan A02/20, Demolition Legend, at D10 : Existing closed or opened door to be demolished. Existing frame to remain. On the same sheet, there is no reference to D10. However, there is an A10 (which is not on the legend of this sheet). Is A10 in fact D10?

Answer : Refer to Addendum A-01, section Drawings, item 2.1.

2. On the architectural plan, is it possible to have the floor to existing as well as to new ceiling heights? It is, among other things, to plan for the height of new partitions.

Answer : Refer to Addendum A-01, section Questions and Answers during Bid, item 11.

3. On the architectural plan, is it possible to have the slab to slab (decking) height? It is, among other things, to plan for the height of new partitions.

Answer : Refer to Addendum A-01, section Questions and Answers during Bid, item 12.

4. On the architectural plan A02, «D5» in the Specific Notes – Demolition, there are five references on the plan that are not on furniture, they are on the floor... Should they be located there? Perhaps these five «D5»'s should be «D6»'s instead ? Please clarify.

Answer : Refer to Addendum A-01, section Questions and Answers during Bid, item 7.

5. On the architectural plan A05, «A7» in the Specific Notes – Construction, there is one reference on the plan that does not correspond to any furniture, symbol, equipment or other. It is in room 134, Room LC-MS. It is located on the floor... Is that where it should be located? Please clarify.

Answer : Yes the note applies to this room.

6. On the construction plan A05, and on the other plans, there is furniture that is not referenced in the Legends. Are these furniture pieces made by laboratory experts or can they be fabricated by cabinet makers?

Answer : Refer to the current Addendum, section Drawings, item 1.3.

7. If indeed these are furniture pieces made by laboratory experts, do you have a suggested product with an approved equivalent?

Answer : Refer to the current Addendum, section Drawings, item 1.3.

8. On the architectural plan A05, CEILING LEGEND, the new suspended ceilings are mentioned as Type 1, 610 x 1220. On the plan however, the tiles are shown as 305 x 1220. Can you please clarify this?

Answer : The base format of the ceiling tile is to be cut according to the ceiling grid shown on the plans.

9. On the architectural plan A06, EQUIPMENT LEGEND, Reference «Q1 : Door or drawer with lock». Is it right to assume that the doors and drawers identified only with «lock» are included in our quantities of Q1? If not, what is the difference between «Q1 with lock» identified in the elevation and «lock»?

Answer : Refer to the current Addendum, section Drawings, item 2.1.

- .1 In the General Notes, replace title « General Notes – Construction (Page A05, A06, A07) » with the following title:

- .3 In the General Notes, Construction (Page A05, A06, A07, A08, A09, A10), add the following General Note 16- :
« *Unless otherwise indicated, all furniture shown are to be provided and installed as part of the scope of the present project. Refer to the specifications, section 12 35 53.13.* ».
