**All bids bonds are to be submitted in hard copy only by the bid closing date and time to the mailing address indicated above.**

**DELIVERABLES / SCOPE OF WORK:**

Work involves dredging five (5) fishing harbours located in the Gaspé Peninsula in the province of Quebec. The total quantity to be dredged for the five (5) harbors is about 8,500 tons. Dredging must be carried out by mechanical ground equipment (excavator with clamshell). Some of the sediment to be dredged will have to be transported to the Belledune landfill site in New Brunswick due to the presence of contaminants. The five (5) harbours to be dredged are:

- Port-Daniel East (Fishermen's Wharf);
- Saint-Godéfrroi (Fishermen's Wharf);
- Bonaventure (Fishermen's Wharf);
- Newport Pointe (Fisherman's Wharf);
- L'Anse-à-Beaufils (Fisherman's Wharf).

The Contractor shall be able to provide dredging equipment capable of reaching a range as shown on the sketch of section 01 11 11 of the Specifications, page 2.

**EXPECTED START AND COMPLETION DATES:**

The services of the Contractor will be commencing upon award of the contract. The expected completion date of this project is **March 31<sup>st</sup>, 2017**.

**MANDATORY REQUIREMENTS:**

- The minimum acceptable amount of Public Liability and Property Damage Insurance is \$2,000,000.00 per occurrence. All tenders **must** be accompanied by confirmation from the tenderer's insurance company that the required insurance will be available upon contract award;
- The tenderer must provide tender security, at the tenderer's own cost, in accordance with the document entitled "Tender Security Requirements" as Bid Security is required for bids over \$100,000. Under these circumstances, the Tender and **original signed Bid Bond** must be delivered to the Closing Location prior to the closing date.

**Note:** All tender securities (Bid Bond) will be returned except that of the successful tenderer (Bidder), which will be retained until the successful tenderer (Contractor) has completed the said contract.
