This amendment 001 is raised to answer questions received from industry as follow:

Q.01: In Annex B, bullet 2 of the single and double bed set:

Single Bed Set *including Bed bug mattress and pillow cover set*: Box foundation with wooden (100% solid kiln dried wood frame), or metal frame, approx. 39"X 72 to 76", fully assembled upon delivery.

Double Bed set *including Bed bug mattress and pillow cover set*: Box foundation with wooden (100% solid kiln dried wood frame), or metal frame, approx. 54"X74 to 76", fully assembled upon delivery.

Can you please confirm that "with wooden (100% solid kiln dried wood frame), or metal frame" is in fact a bed frame and not the desired composition of the box foundation?

A.01: Correct, the specified composition is for the bed frame.

Q.02: Part – 3, Offer preparation Instructions. Canada 'requests' that Offerors provide their offer in separately bound sections as follows.

Is the use of 'request' in the current solicitation to be interpreted as optional or mandatory?

A.02: Optional. The only mandatory requirement in terms of bid presentation is "Prices must appear in the financial offer only. No prices must be indicated in any other section of the offer."

Q.03: Part – 3.1, Section 1: Technical Offer. In their technical offer, Offerors should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work in the time periods specified in Annex A – Requirement.

Part – 4, Evaluation Procedures and Basis of Selection, 4.1.1 (b) Offers for each area of performance will be evaluated on a per area basis.

4.2 – Basis of Selection, An offer must comply with the requirements of the Request for the Standing Offer to be declared responsive for each area.

Will previous poor service and lack of adherence to S.O. requirements and requests be considered when evaluating the technical offers?

A.04: Yes. Canada will assess the Offeror against the requirements of this solicitation, not the subcontractors. The Offerors are free to use any subcontractor and the Offeror is responsible for their performance.

Q.05: Part – 3.1, Section 1: Technical Offer. In their technical offer, Offerors should explain and demonstrate how they propose to meet the requirements and how they will carry out the Work in the time periods specified in Annex A – Requirement.

Should the Offeror submit an offer for more than one area of performance, the Offeror should demonstrate how they will fulfill the requirement(s) for supply, delivery, assembly, set-up and disposal of packing material at the same time in multiple cities or provinces.

Can you confirm that only a brief narrative is required to describe how we propose to meet the requirements and that if submitting for more than one area, we would also describe how we would fulfil requirements at the same time?

A.05: Yes, only a brief narrative is required. If submitting for more than one area of performance, the Offeror would have to describe how they would fulfil the requirement in multiple cities simultaneously.

All other Terms and Conditions remain unchanged.
