Questions and Answers- 3rd Series

Q-23: Can you confirm that the current provider's management resources possess all the required qualifications, particularly the requirement for experience as a peace officer? In the case that they are not peace officers, it is our understanding that to achieve maximum points we would not be able to keep any of the current management staff because they do not meet the requirements described in the tender.

Since we have a policy that encourages retaining the staff currently in place in order to minimize interruption to service, should we conclude that we would not be able to hire the current operational resources if awarded the contract? We can propose resources who meet the requirements, but this will mean that you will lose the current staff. Would it not be appropriate then to remove this requirement from the evaluation grid?

A-23: All resources under the current contract must meet the requirements of that particular contract. We cannot confirm whether or not the current resources possess this experience as it may not have been included as a part of the requirements. The Bidder is also not required to obtain maximum points for the point-rated criteria but rather to meet the minimum global pass mark as identified in Annex I-Technical Evaluation Criteria. The requirement to retain existing resources is applicable only to security guards and not management.

Q-24: Some of our operational resources possess all the required qualifications, but do not yet have their valid security agent's license issued by the BSP. The timelines at the Bureau de Sécurité Privée to obtain the license is 6 to 8 weeks. Would it be possible to get an extension of 6 to 8 weeks, after contract award, to provide you with a valid copy of the license for these resources?

A-24: To work under the contract, the resources must possess the required licenses. Copies of these licenses are required prior to contract award. Given our operational requirements, we cannot permit an extension of 6 to 8 weeks after contract award to present the licenses.

Q-25: Can you provide the seniority list for each position? As per the current collective agreement, different rates apply and this would allow us to estimate the applicable seniority rates for each resource.

A-25: We do not have any data on this subject.

Q-26: Is it possible to disclose the hourly rates for each operational post (Operational Security Manager, Assistant Operational Security Manager)?

A-26: It is not possible for us to provide you with this information; however, an Access to Information request may provide information on the subject.
