QUESTIONS AND ANSWERS

Q1: Can you please clarify the scope of the above request for standing offer? It appears this is set up for small construction projects up to the maximum dollar range stated. Please confirm this is not a service or maintenance contract for service calls (i.e. go fix a broken toilet at 2am in Edmondson).

A1: The standing offer is set up for a variety of minor construction work at all Federal Assets. It can be fixing a broken toilet at 2:00am in the morning if there's a requirement/emergency for it. Each scope of work will be developed by each project manager. It can cover emergency repairs if required. This standing offer covers a variety of work.

Other examples of work include:

- Supply and Installation of New kitchen counters.
- Supply and Installation of New Garage Doors.
- Construction of new sidewalks.
- Drilling a new well.
- Cleaning out water intake lines.
- Supply and installation of new windows.
- Paving a parking lot.
- Upgrades to the electrical or ventilation systems.
- Installation of an emergency power system.
- Demolition of a building.

Q2 : What buildings does this apply to?

A2: The work done under the standing offer can be at any Federal Government Building or assets within the counties indicated for the North Section and the South Section, including associated Islands.
