TITLE: RISO MECHANICAL PRECISION FABRICATION

The purpose of this amendment is to issue a Question and Answer about this Request for Standing Offer.

QUESTION 1

The criteria no. 2 - "EXPERIENCE OF THE PERSONNEL DIRECTLY INVOLVED IN THE PROJECT" in Section 4.1.1.2 of Part 4 of the Demand for Standing Offer states: "The Offeror should provide a document describing the experience of five full-time machinists (30 hours per week or more) working for the Offeror".

Subsequently, "the offeror should indicate in a table the experience of each technician in terms of months. The technicians' scores will be added together and divided by the number of proposed resources, to obtain the average".

Does the offeror has to provide a table with all his technicians or only the 5 most qualified ones?

RESPONSE 1

The offeror should indicate in a table the experience in terms of the months of the five technicians whose description of experience has been provided. In order to obtain an average, the technicians' scores will be added together and divided by the number of proposed resources, that is to say the 5 resources for which the description of the experiment has been provided.

To obtain points under criteria number 2, the offeror must submit a description of the experience of 5 technicians.

All other terms and conditions remain unchanged.
