25	<p>Corporate Technical Point Rated R4 asks that the bidder demonstrate its ability to provide mainframe professional services related to operational support of Shared Services Canada/PWGSC departmental z/OS mainframe systems and associated software. The bidder will be awarded points by providing reference projects that fully demonstrate its corporate experience with "System Administrator - Mainframe z/OS Networks".</p> <p>We would like to confirm our understanding that the only acceptable experience to meet this requirement is for network support which has been provided directly on the mainframe operating systems, z/OS and z/VM. This would include support for TCP/IP and SNA components such as VTAM on those operating systems, but would exclude support for any network components which are outboard from the mainframe system itself.</p>	Correct.. excludes support to network components outboard of z/OS or z/VM.
