**Section 1: Questions and Answers (Set 5)**

Note: Questions are numerically sequenced upon arrival at PWGSC. A question and its answer will be provided via BuyandSell as the response becomes available. Potential bidders are therefore advised that questions and answers may be issued via BuyandSell out of sequence. The following questions have been received. In accordance with Article 13 under 2003 Standard Instructions - Goods or Services - Competitive Requirements (2016-04-04) which has been incorporated into the RFP in accordance with Article 2.1 of Part 2 of the RFP, the questions and corresponding answers are provided to all potential bidders as set out below:

Q22. Does each member of a Joint Venture have to hold the insurance requirements (CGL, E&O, Medical Malpractice) or can one member hold the insurance as long as the contract is covered by the policy?

A22. No. As long as one member of the joint venture holds the insurance policy that includes the other members as "additional insured" on the insurance certificate.

Q23. Can you please explain how the median  $\pm$  35% is calculated? If we are above or below the 35%, will we have the option to submit a Financial Bid Revision?

A23. Please see Amendment 005, response A19 for the revision at article 4.6 - Basis of Selection, sub-article 4.6.5.1 ((c)) as well as the revision at table at 4.6.6 provided as an example.

No, a Financial Bid Revision is not permitted under the scenario. Financial Bid Revision only applies as per article 4.3.2.1.

Q24. Please extend this proposal for a two month period? This is a large undertaking that involves national coordination and research. The incumbent firm would not need to perform this type of coordination or research and as such has an advantage over other firms. Therefore, a two month extension would help in leveling the playing field for all bidders.

A24. No. Canada has reviewed your request, the requirement remains unchanged.
