Where the project duration is greater than four (4) months this will be assessed as equivalent to more than one (1) project based on extended duration. For example only, a project that was ten (10) months in length would be counted as the equivalent of two (2) projects, with no proration given for any remainder'.

However, the Resource Project Template with respect to **Date / Duration of engagement** (indicate MM/YY to MM/YY) states 'Note engagements must be a minimum duration of six (6) months in order to be considered.'

Please clarify the minimum duration months for each cited project to be considered for each of the Resource Categories described in this RFP.

Is the crown requesting the bidder provide a client contract number associated within each of the resources referenced projects?
