Amendment #5

Please note the following clarifications:

1) Please note that the maximum funding indicated at 2.6 Maximum Funding of \$1,725,000.00 includes 15% HST. The maximum funding before any applicable taxes is \$1,500,000.00

2) Part 4, 4.2 Basis of Selection, the following line is deleted:

"c. obtain the required minimum of 50 points overall for the technical evaluation criteria which are subject to point rating. The rating is performed on a scale of 100 points."

And the following line is inserted in its place:

"c. obtain the required minimum of 55 points overall for the technical evaluation criteria which are subject to point rating. The rating is performed on a scale of 100 points."

(as per the revised Point-Rated Evaluation Criteria minimum requirement indicated in Amendment #3)

3) Please note that 7.7.2 Limitation of Price, this entire paragraph is deleted, and is replaced with the following:

"7.7.2 Limitation of Expenditure

The Contractor will be reimbursed for the costs reasonably and properly incurred in the performance of the Work, and profit, as determined in accordance with the Basis of Payment in Annex C , to a limitation of expenditure of \$_____ (insert amount at contract award). Customs duties are included and Applicable Taxes are extra."

4) Please note that it is anticipated a preliminary information document from Ocean Networks Canada will be posted to buyandsell via an amendment within the coming week. An important piece of information that will be forthcoming in this document is that the ONC oil-filled cable described in the Statement of Work (Annex A, Technical Specification, Section 19) will be provided to the contractor at no charge.

5) Please note the following Q&A:

In section 4.2 Basis of Selection, item 1.b (top of page 9 of 23) - it states to be declared responsive, a bid must "meet all mandatory technical evaluation criteria".

Can you please confirm that "mandatory technical evaluation criteria" is the contents of the table (with headings "#", "Specification", "Criteria") that begins on page 12 of 22 of the Statement of Work and ends on page 18 of 22?

Yes, this is correct. Mandatory technical evaluation criteria are found within Annex B – Evaluation Criteria under the aforementioned columns of the Solicitation. These requirements must be met in a bid.

6) In the event of a tie between bidders after the completion of the Point-Rated Evaluation, the lowest priced bid would determine the winner.

All other terms and conditions remain unchanged.
