AMENDMENT #001

The intent of this amendment is to answer questions from potential bidders and revise areas of the Request for Proposal document.

Q1. Are delivery fees on equipment considered part of the "Call-in" rates or are they to be considered a disbursement to be invoiced?

A1. All costs associated with rental of non-standard equipment is considered a disbursement.

Q2. Why is there no "Call-in" for the riding lawnmower?

A2. The Call in rate is directly related to personnel who operate the equipment.

Q3. Is the rate for the "Bucket truck with boom" to include the operator?

A3. No, the daily or weekly rate for a bucket truck with boom does not include the operator.

Q4. What tasks will the Bucket Truck with Boom be expected to perform, and what kind of credentials will the operators need, ie. hydro, arborists etc?

A4. A bucket truck with boom may be required for tree cutting or trimming

Q5. What size of dump truck will be needed? Is this a tri-axle dump truck?

A5. A 20 cubic yard dump truck will suffice. Annex "B", Pricing Basis "C" has been revised to add this information.

Q6. What tasks will the Dump Truck with Plow be performing? Is this for snow removal or grading purposes?

A6. The dump truck with plow's intended use is for snow removal.

Q7. If the plow is needed for gravel grading purposes can we supply a rate for an independent plow and dump truck?

A7. Please refer to Q6 and A6

Q8. Are there people residing on property?

A8. Yes

Q9. Is the property open for inspection?

A9. The property can be inspected during a scheduled site visit (date and time would be included as an amendment to this solicitation) and allow all potential bidders to attend.

Q10. Do I need to report to security?

A10. If a site visit were to be scheduled, potential bidders would need to report to security at the gate.

Q11. I will do a drive by on the outer perimeter then make an attempt to drive inside property. Is there a person dictated to accommodate a site visit?

A11. You are free to drive by the outer perimeter using public roads. If a site visit were to be scheduled, representatives would be made available to accommodate the visit.

Q12. Is there someone from Stony point who is working in conjunction with DND that I can talk to while there?

A12. It would be unfair to all potential bidders if contact information is provided to allow one bidder to obtain information that could result in an unfair advantage. As noted in the Request for Proposal, Part 2, #2.4: "All enquiries must be submitted in writing to the Contracting Authority".

Bidders who do not attend or do not send a representative will not be given an alternative appointment but they will not be precluded from submitting a bid. Any clarifications or changes to the bid solicitation resulting from the site visit will be included as an amendment to the bid solicitation.
