## REQUEST FOR QUOTATION AMENDMENT NO. 003

### Request for Quotation Amendment no. 003 is raised for the following reasons:

- Publish Canada's Responses to Bidders' questions.
- Amend the quantity of deliverables for Mouse A from 3,052 units to 2,500 units.

NOTE: Bidders' questions are numerically sequenced upon arrival at SSC. Bidders are hereby advised that questions and answers for this solicitation may be issued via BuyandSell.gc.ca out of sequence.

### Question 2:

Mouse A, Ambidextrous Mouse. The Logitech mouse you have tested and considered acceptable the Logitech anywhere mouse 2 is not actually Ambidextrous the thumb buttons are for a right handed user, can you please ensure that you are ok with this mouse not being exactly Ambidextrous.

### Answer 2:

Yes. The Mouse A (Annex A, Line Item no. 1 & 3) requirements will be amended accordingly. Please see attached Amended Annex A – List of Deliverables and Prices.

Under Annex C – Statement of Requirement:

DELETE:

Mouse A: Advanced Ambidextrous

REPLACE with:

Mouse A:

1. The scroll function must be offered in the centre of the mouse.
2. Mouse must employ laser sensor technology and have a minimum 1000 dpi movement resolution.
3. Mouse must have two, native connectivity options: USB 3.0 connected (employing a 2.4 GHz. wireless bandwidth) and Bluetooth vers. 4.0 (must not involve a dongle for use).
4. USB receiver (dongle) must be universally functional and compatible with all other identically branded mice shipped. The receiver must not be specific to just one mouse.
5. The mouse must have both USB 3.0 connectivity and Bluetooth connectivity which allows for a connection on two separate devices. The mouse must have the ability to toggle between those two devices through the use of an integrated button specifically designed for that function.
6. Mouse dimensions must be within 2 millimeters (mm.) of 62 mm. in height, 101 mm. in width, 35 mm. in depth.
7. Mouse must be fully compatible with and support all the related features of Microsoft Windows 7 Pro and Windows 10 Pro (Anniversary Update).
8. Mouse must come with an internal rechargeable battery. Charging must be achieved through a micro-USB cable.

**Questions 3:**

Delivery times lines and the penalties for late delivery.

Logitech does not have all of the stock on 1 of the items they have made this very clear, they are making every reseller who is bidding on this aware,

Shared services Canada should remove the penalty fees, and adjust the contract for what the manufacture has available in the 6 weeks' notice of this RFP, once the contract is awarded. I.E. asking for 3052, Manufacture can only delivery 2420 contract should be adjusted to the amount.

**Answer 3:**

The Quantity will be reduced from 3,052 to 2,500 for Mouse A. See attached amended Annex A – List of Deliverables and Prices.

**Question 4:**

I have a question regarding shipping on the optional quantities if the client or any other client exercises the right to purchase.

Part 6.10 ( c ) Canada reserves the right to add new delivery and invoicing locations when exercising the optional quantities.

Q - Since the initial deliverables and shipping are calculated for Ottawa will the winning bidder be able to charge shipping costs on optional quantities if the address has changed, as this is the case with monitor and desktop RVDs options?

For additional Hardware delivered to SSC Clients, if Canada exercises its option through amendments to the Contract, Canada will pay the Contractor the firm price(s) set out in Annex A – List of Deliverables – Initial Client Options, FOB destination, including all customs duties, Applicable Taxes extra. Shipping fees, if applicable, are part of the system price but are shown as a separate line item.

Identified Users are responsible to pay for any Environmental Handling Fee (EHF) applicable to their order at cost, and based on the delivery address(es).

Canada reserves the right to modify new delivery and invoicing locations when exercising the optional quantities. Should Canada exercise this right, the Contractor may modify the shipping currently priced in the Contract. However, shipping from the Contractor's Canadian Facility to the Identified User will be paid to the Contractor at cost and must be identified as a separate line item on the invoice. Canada may at any time request a copy of the shipping invoice to substantiate shipping charges. Any costs associated with shipping the deliverables from an international location to Canada, including shipping costs, customs, or duties, among others, must be included in the unit price of the deliverable.

**The Total Price of the Initial Client Options will not be included in the Total Estimated Cost indicated on page 1 of the Contract until an amendment is issued to exercise this option.**

**Question 5:**

Will SSC and STATS allow for a partial delivery of Mouse A?

**Answer 5:**

Delivery must be made in accordance with Section 6.8 Delivery Date of the RFQ. See amended Annex A for revised quantities.

**Question 6:**

Can you confirm that the client has physically tested both the Logitech MX Master and MX Anywhere Mouse 2?

**Answer 6:**

Yes. The Client has tested both the Logitech MX Master and MX Anywhere Mouse 2. Still, as per Section 2.6 Test Units of the RFQ, Canada is entitled to request a test unit during the bid evaluation phase.
