At page 4, Article 4. REQUIREMENT DESCRIPTION:

DELETE:

On behalf of the federal government, NRCan is seeking high resolution optical satellite imagery and services. To meet the requirements of the Contract, the Contractor must provide the following:

- A. High resolution optical imagery covering the landmass of Canada henceforth referred to as National Coverage Imagery to serve the needs of the federal, provincial and territorial governments. The National Coverage Imagery will be discovered and accessed through the following components: Web Portal Imagery, a Web Coverage Service and a Geographical Prioritization System.
- B. Optical imagery covering the landmass of Canada to serve the needs of all Canadians, henceforth referred to as Open Imagery of Canada. The Open Imagery of Canada will be discovered and accessed through the following components: a File Transfer Protocol and a Web Mapping Service.

NRCan acknowledges that it is possible that these items (A and B) have differing resolutions. It is anticipated that up to two (2) contracts may be awarded for this requirement.

INSERT:

Canada is seeking the following High Resolution Optical Satellite Imagery and services:

- A. High Resolution Optical Imagery covering the landmass of Canada henceforth referred to as National Coverage Imagery to serve the needs of the federal, provincial and territorial governments. The National Coverage Imagery is composed of three types of imagery: Standard Imagery, Full Satellite Imagery (optional) and Stereo Pair Imagery (optional). The National Coverage Imagery will be searched, discovered and accessed through three access methods: a Web Portal, a Web Coverage Service and an Application Programming Interface (desirable).
- B. Optical imagery covering the landmass of Canada to serve the needs of all Canadians, henceforth referred to as **Open Imagery of Canada**. The Open Imagery of Canada is composed of a static product (Open Mosaic of Canada) and a dynamic product (Open Web Canada).

Canada acknowledges that it is possible that these items (A and B) may have differing resolutions.
