The following changes/clarifications in the tender documents are effective immediately. This Addendum will form part of the Contract Documents.

Response to Bidder's Inquiries:

Please find below a response to bidder's inquiries received to date.

- 1. In reference to: RS – 1 General Requirements – Please describe that type of facilities that might be included in this Request for standing offer. The RS – Required services identify the services that might be required, but does not advise the type of facility other than The Department of Fisheries & Oceans (DFO), Small Craft Harbour. Please describe the range of possible work. (I.e. Dock infrastructure repairs to shore power, lighting on docks and/or of parking areas, renovations to washrooms, small office renovations, building of small warehouse, etc?).**

The type of facilities are what can be normally be found in a small craft harbour type harbour; experience should relate to these structures or facilities that are exposed to the marine environment. The range of work has been provided in section RS-2, please review.

- 2. In reference to SRE 1 General Information:**

- a. 3.1.2 page 52 Licensing, Certifications or Authorization. Please confirm: what certification documents that DFO is expecting. IF documents are to be provided- can they NOT be a part of the 11 pages page count. If a statement that we met the requirements is expected then can we add the statement be added to the Declaration/Certification Form?**

For this requirement, proof that the company meets the licensing agreement is necessary. Please indicate current license(s) as a statement included in the cover letter.

- b. 3.2.1 Comprehension of the Scope of Work-Item 2 indicates a recommendation of 1 page total. With respect to this as outlined in our first item it is not clear what service we would provide to DFO as there is no specific description of what the anticipated works would form part of the Electrical consulting services. To provide a detailed description of our Comprehension of the Scope we would need some examples or possibly descriptions of Hypothetical Projects that would be developed at the Harbours. Considering this is an important part to our submission it is difficult to address this in one page. Is it possible to increase the Page limit from 11 to something like no more than 15 pages ? Please review and confirm.**

- c. **3.2.2 Team Approach- Item 2- indicates a recommendation of 1 page total. Considering this is an important part to our submission it is difficult to define this in one page. Is it possible to increase the Page limit from 11 to something like no more than 15 pages? Please review and confirm.**

The one page limit for the "Team Approach" section is a recommendation only, and is not mandatory.
